## General Election

### November 5th, 2024

The General Election will be held at the Village Hall on Tuesday, Nov. 5<sup>th</sup>. Hours: 7 a.m. to 8:00 pm.

**Absentee Ballots are available.** Clerk's Hours: Monday, Tuesday, Wednesday 9 to noon & 1:00 to 4:00. Or make an appointment by calling 920-348-5156.

You WILL be required to show a photo ID. Are you new to the village and have not registered to vote? Please stop in at the Clerk's Office to register. You will be required to provide proof of residency. You must have lived in Friesland at least 28 days.

In Person Absentee Voting is available beginning **October 22 through Friday, November 1**. Please call if you need to use this option to schedule a time.

At [myvote.wi.gov](https://myvote.wi.gov) you can register to vote or check your voter registration status. You are also able to register to vote in the Village Clerk's Office anytime the office is open prior to an election or on Election Day.

## Trash & Recycling Reminder

Garbage is picked up on Thursdays UNLESS a holiday falls on a Thursday. **Thanksgiving Day falls on Thursday, November 28. The garbage and recyclables will be picked up on Friday, Nov. 29<sup>th</sup>!**

## Leaf Pickup

The Village Board encourages you to take advantage of leaf pickup to avoid burning.

**\*It is important to rake your leaves only to the street, please make sure there are NO STICKS OR BRANCHES in the leaf piles. PLEASE DO NOT BAG OR BOX THE LEAVES!** Your leaves will be picked up using our leaf vacuum. Leaves will be picked up during October and November; **there will be no pickup after November 30.**

## Leaf Burning is Allowed

Burning of leaves and yard debris is allowed **only between October 1<sup>st</sup> and November 30<sup>th</sup>**. Hours allowed are only between 4-7 p.m. **NO NEED TO BURN if your leaves are picked up!**



## Winter Parking Prohibited

Section 10-1-27 Village of Friesland Ordinance states: No vehicle shall park upon traveled streets/roadways located in the Village of Friesland between **December 1<sup>st</sup> and April 1<sup>st</sup>** of the following year between the hours of 12 midnight and 6 a.m. (except for emergency vehicles).



## **Flushable Wipes ARE NOT FLUSHABLE!**

Again, we are reminding you that our sewer pumps ARE NOT GRINDER PUMPS! We have had 2 pump failure repairs at the **North Madison Street lift station** located by the village park in 2023. The most common items found inside the pump are the "flushable" wipes. **THEY DO NOT DISSOLVE! Please throw them into the trash!!** Also found are feminine hygiene products and prophylactics. We have even found T-Shirts and toys in the pump.
