#### ELECTION POLL WORKERS WANTED

\*\* The Village of Friesland is looking for Poll workers for next year's elections. If interested, please contact the Village office at 920-348-5156.

Candidates must meet the following:

- Be at least 18 years of age.
- Be a resident of the election district for the 28 days before the election.
- Complete required training
- Be a student 16 years or older, enrolled in a high school with a minimum GPA of a 3.0. You may work with written permission from a parent or guardian and school principal.
- Never have had been convicted of a felony and not otherwise disqualified from voting.

At <u>myvote.wi.gov</u> you can register to vote or check your voter registration status. You are also able to register to vote in the Village Clerk's Office anytime the office is open prior to an election **or** on Election Day.

#### **2024 Dog License**

You are required by state law to buy a license for your dogs. You will need to supply proof of a valid and current rabies vaccine information. Licensing form can be found online at villageofFriesland.com. Fee: Fixed \$3 or intact \$8. Late charges will be enforced after April 1st, 2024. The late charge is \$10.00 per dog. Starting JUNE 2024 owners will be turned over to Columbia County for enforcement of village ordinances. The maximum number of dogs allowed is 2!

#### **Winter Parking Ordinance**

Section 10-1-27 Village of Friesland Ordinance states: No vehicle shall park upon traveled streets/roadways located in the Village of Friesland between December 1<sup>st</sup> and April 1<sup>st</sup> of the following year between the hours of 12 midnight and 6 a.m. except for emergency vehicles.

Reminder: Columbia County will issue citations to violators!

## Real Estate Tax Payments Due 1/31/2024

Real Estate Tax Payments are due to the Village of Friesland by January 31. If you wish, you may pay the first installment by that date and pay the second payment to the Columbia County Treasurer by July 31, 2024.



# Trash & Recycling Container Spacing

Columbia County Solid Waste picks up your containers with a lift arm on the truck. It is VERY IMPORTANT to place your containers **3 FEET APART** to allow the truck to empty the containers.

## Flushable Wipes ARE NOT FLUSHABLE!

Again, we are reminding you that our sewer pumps ARE NOT GRINDER PUMPS! We have had 5 pump failure repairs at the **North Madison Street lift** station in 2022. The most common items found inside the pump are the "flushable" wipes.

## THEY DO NOT DISSOLVE! Please throw them into the trash!!

Also found are feminine hygiene products and prophylactics. We have even found T-Shirts and toys in the pump.
